## NOTICE OF PROTEST HEARING

**NOTICE IS HEREBY GIVEN** that on **Monday, May 24, 2021, at 10:00 a.m.**, at the Joint Chambers – Basement Level, 1010 10th Street, in Modesto, the Stanislaus Local Agency Formation Commission (LAFCO) will conduct a Protest Hearing regarding:

**LAFCO APPLICATION NO. 2020-01, MUNICIPAL SERVICE REVIEW NO. 2020-03 & SPHERE OF INFLUENCE UPDATE NO. 2020-03 – SALIDA STORM DRAIN REORGANIZATION TO COUNTY SERVICE AREA 4**

Description: Request to annex the Salida community (approximately 1,532 acres) into County Service Area (CSA) 4 to provide storm drain services and extend the assessment rate to the entire Salida area. The proposal includes a divestiture of storm drain services from the existing CSA 10 and detachment of the Landmark Business Park area from CSA 10. An updated Municipal Service Review and Sphere of Influence were also prepared for the proposal.

Purpose of Protest Hearing: On March 24, 2021, the Stanislaus Local Agency Formation Commission heard and approved the above proposal and adopted LAFCO Resolution No. 2021-03. The Commission's decision is subject to the outcome of a Protest Hearing, where landowners and registered voters can submit their written opposition to the proposal.

How to Protest: Any owner of land and/or registered voter within the affected territory who disapproves of the reorganization may file a written protest against the proposal with the Executive Officer at any time **prior to the conclusion of the protest hearing**. A Protest Form is attached for your use. You may also use the Protest Form that is available on the Stanislaus LAFCO website at: [www.stanislauslafco.org/info/forms](http://www.stanislauslafco.org/info/forms). Please be sure to include your name, address of land owned within the affected area (if different from your residence), Assessor's Parcel Number and the name of the proposal. Include your signature, and the date signed.

Protest forms can be submitted in the following ways:

- **Mail or hand-delivered to Stanislaus LAFCO at 1010 10<sup>th</sup> Street, Suite 3600, Modesto CA, 95354 by May 24, 2021 at 10:00am. (Postmarks cannot be accepted.)**
- **Hand-delivered during the Protest Hearing on Monday, May 24, 2021 at 10:00am at the Basement Chambers at 1010 10<sup>th</sup> Street, in Modesto.**

*If you are not opposed to the reorganization, you need not take any action.*
