## NOTICE OF PROTEST HEARING

**NOTICE IS HEREBY GIVEN** that on **Wednesday, August 29, 2018, at the hour of 10:00 a.m.**, at the Oakdale Rural Fire Protection District Station 3, 13200 Valley Home Road, in Valley Home, the Stanislaus Local Agency Formation Commission (LAFCO) will conduct a Protest Hearing regarding:

### **LAFCO Application No. 2017-03 and Sphere of Influence Modification No. 2017-07 – Division 1 North Area Change of Organization to Oakdale Rural Fire Protection District**

**Description:** A request by the Oakdale Rural Fire Protection District to expand the Sphere of Influence and annex approximately 57,595+/- acres to the District. The proposed project area is located in the northernmost area of Stanislaus County, adjacent to San Joaquin and Calaveras Counties. The purpose of the request is to allow the District to provide continued services and extend its special tax to the area.

**Purpose of Protest Hearing:** On June 27, 2018, the Stanislaus Local Agency Formation Commission heard and approved the above proposal and adopted LAFCO Resolution No. 2018-05. The Commission's decision is subject to the outcome of a Protest Hearing, where landowners and registered voters can submit their written opposition to the proposal.

**How to Protest:** Any owner of land and/or registered voter within the affected territory who disapproves of the annexation may file a written protest against the proposal with the Executive Officer at any time **prior to the conclusion of the protest hearing**. A Protest Form is attached for your use. You may also use the Protest Form that is available on the Stanislaus LAFCO website at: [www.stanislauslafco.org/info/forms](http://www.stanislauslafco.org/info/forms). Please be sure include your name, address of land owned within the affected area (if different from your residence), Assessor's Parcel Number and the name of the proposal. Include your signature, and the date the signed.

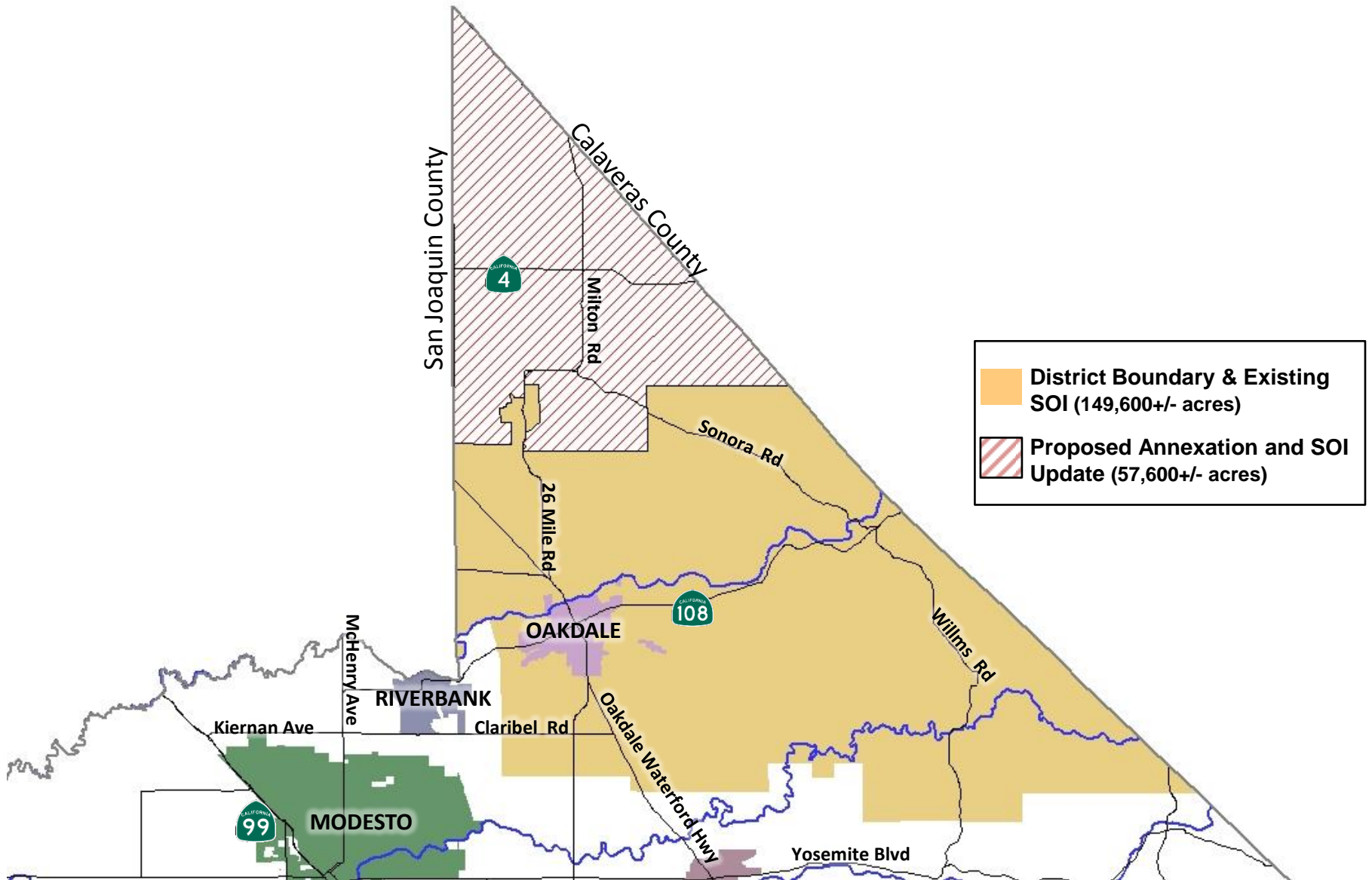
Protest forms can be submitted in the following ways:
